I hereby waive any rights to a cause of action or future cause of action I may have against Penny Lane Farm Sanctuary and its directors, officers, agents, representatives, and members, and release discharge, indemnify, and hold harmless Penny Lane Farm Sanctuary and its representatives from and against all claims, actions, costs, expenses, and demands, in respect to the following, not limited to death, injury, loss or damage to person or property, arising out of or in connection with my visiting, howsoever caused, even if such loss or injury is caused by the negligence or default of Penny Lane Farm Sanctuary and its representatives
7. I agree that Penny Lane Farm Sanctuary is not responsible for any loss or damage to any of my personal property or possessions, including vehicles, no matter what the cause of said loss or damage may be.
